RESOLUTION NO. 2026-006

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF
CASTLE ROCK APPROVING THE RENAMING OF SOUTH
INTERSTATE 25 ROAD TO SOUTH WILCOX STREET**

WHEREAS, the East Frontage Road (a/k/a South Interstate 25 Road) is located within Douglas County (the “County”) on the east side of Interstate 25 and extends south from Plum Creek Parkway in the Town of Castle Rock (the “Town”) to the Town of Larkspur; and

WHEREAS, on June 27, 2023, the Town entered into an Intergovernmental Agreement (the “2023 IGA”) with the County, whereby the County transferred ownership of several parcels to the Town that had been acquired for the sole purpose of constructing the Interstate 25/Crystal Valley Interchange (“CVI”); and

WHEREAS, pursuant to the 2023 IGA, the Town agreed, subject to the approval of Town Council, to annex the parcels acquired from the County to the Town; and

WHEREAS, in conjunction with the annexation process, Town staff is initiating the process of renaming that portion of South Interstate 25 Road located within the Town as South Wilcox Street; and

WHEREAS, a continuous South Wilcox Street corridor within the Town will significantly improve navigation for emergency responders, establish clear boundaries for law enforcement, and make the delivery of services to Town residents more efficient; and

WHEREAS, in accordance with established Town and County policy, Town staff has submitted a formal referral request to the County Planning and Addressing office, identifying the name being proposed for the street and any address changes that will be required; and

WHEREAS, in addition, Town staff has solicited feedback from the 61 business and residential addresses that will be affected by the proposed change and has received only comments that are in favor of the proposal; and

WHEREAS, Town staff has estimated that the total costs anticipated to be incurred by individual businesses and residents as a direct result of the change will not exceed \$45,000; and

WHEREAS, the Town’s Public Works Commission has formally recommended that Town Council authorize Town staff to take whatever actions may be necessary to complete the street name change and to reimburse individual businesses and residents for reasonable costs they may incur; and

WHEREAS, the Town Council finds and determines that renaming that portion of South Interstate 25 Road located within the Town as South Wilcox Street is in the best interests of the Town, its businesses, and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK, COLORADO AS FOLLOWS:

Section 1. Approval. The Town Council hereby authorizes Town staff to take whatever actions may be necessary to rename that portion of South Interstate 25 Road located within the Town as South Wilcox Street and to reimburse individual businesses and residents adjacent to the street for reasonable costs they may incur up to and including a total cumulative amount of \$45,000.

Section 2. Contingency. Notwithstanding any provision of this Resolution to the contrary, the change in street name authorized by this Resolution shall not take effect until such time as the parcels transferred from the County to the Town pursuant to the 2023 IGA are formally annexed to the Town.

PASSED, APPROVED AND ADOPTED on first and final reading this 20th day of January, 2026, by the Town Council of the Town of Castle Rock, Colorado, by a vote of 7 for and 0 against.

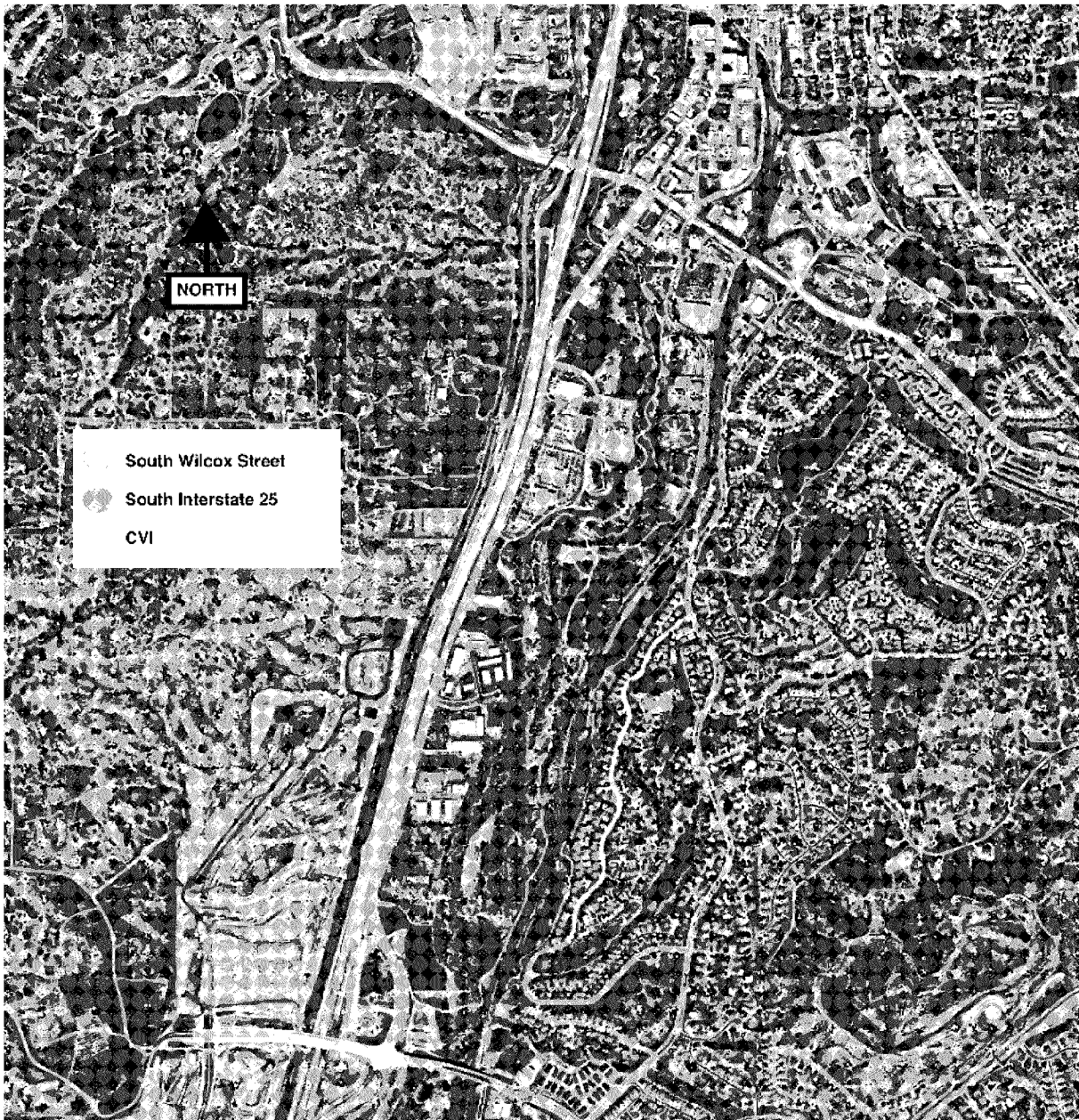
