PURPOSE

THE PURPOSE OF THIS AMENDED PLAT IS TO RECONFIGURE THE RIGHT-OF-WAY WIDTH FOR UMBER CIRCLE FROM 50-FOOT WIDE TO 44-FOOT WIDE, EXTENDING THE EXISTING LOT LINES TO THE NEW RIGHT-OF-WAY CONFIGURATION. NO LOT LINES WERE MOVED (OTHER THAN NOTED ABOVE) WITH THIS REPLAT.

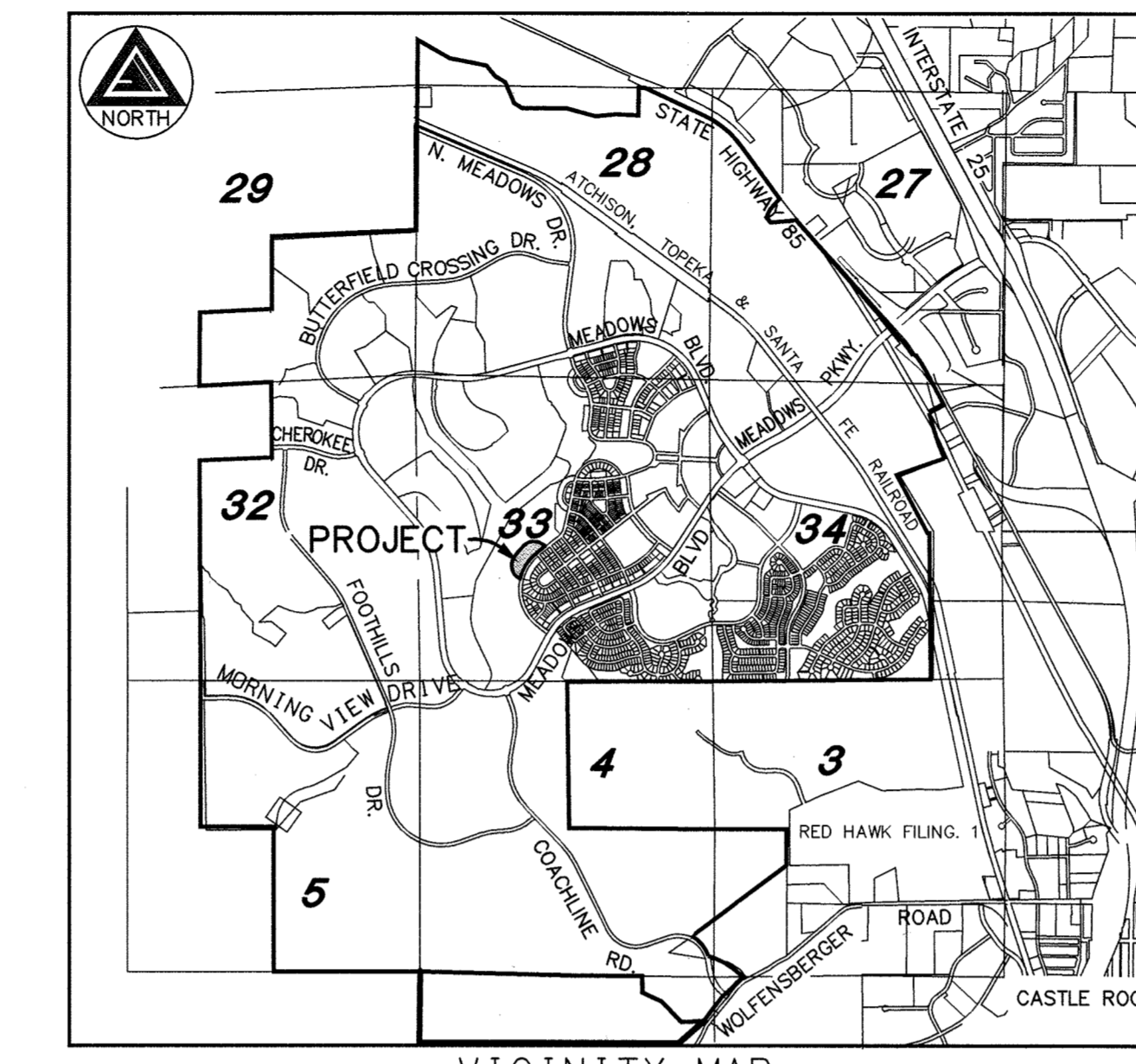
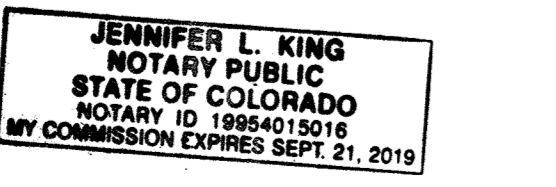

LANDSCAPING SHALL BE CONTINUOUSLY MAINTAINED INCLUDING NECESSARY WATERING, WEEDING, PRUNING, PEST CONTROL AND REPLACEMENT OF DEAD OR DISEASED PLANT MATERIAL. UPON WRITTEN NOTICE BY THE TOWN, THE OWNER WILL HAVE 45 DAYS TO CURE OR REPLACE DAMAGED OR DEAD LANDSCAPE MATERIAL. IN THE CASE OF DISEASED LANDSCAPE MATERIAL, A SHORTER COMPLIANCE PERIOD MAY BE SPECIFIED IN SAID NOTICE. THE TOWN OF CASTLE ROCK WATER CONSERVATION ORDINANCE REGULATES TIMES OF SEASONAL IRRIGATION AND PROHIBITS THE WASTING OF POTABLE WATER THROUGH IRRIGATION.
- PURSUANT TO SECTION 14.02.040 OF THE TOWN OF CASTLE ROCK MUNICIPAL CODE, THE TOWN OF CASTLE ROCK HEREBY ABANDONS ALL PREVIOUSLY PLATTED EASEMENTS AS SHOWN ON THE MEADOWS FILING NO. 20, PHASE 2, AMENDMENT NO. 3 FINAL PLAT, WITHIN THE BOUNDARIES OF THIS PLAT UNLESS OTHERWISE SHOWN OR NOTED HEREON.
- PURSUANT TO SECTION 14.02.040 OF THE TOWN OF CASTLE ROCK MUNICIPAL CODE, THE TOWN OF CASTLE ROCK HEREBY ABANDONS ALL OF UMBER CIRCLE CREATED BY THE MEADOWS FILING NO. 20, PHASE 2, AMENDMENT NO. 3 FINAL PLAT, DEPICTED HEREON.
- THE UTILITY EASEMENTS AS SHOWN HEREON ARE FOR THE INSTALLATION, MAINTENANCE AND OPERATION OF UTILITIES AND UTILITY FACILITIES INCLUDING, BUT NOT LIMITED TO, ELECTRIC LINES, GAS LINES, CABLE TELEVISION LINES, FIBER OPTIC LINES AND TELEPHONE LINES, AS WELL AS PERPETUAL RIGHT FOR INGRESS AND EGRESS FOR INSTALLATION, MAINTENANCE AND REPLACEMENT OF SUCH LINES; UTILITY CROSSINGS MAY BE PERMITTED IN OTHER UTILITY OR DRAINAGE EASEMENTS PROVIDED THAT ANY NECESSARY CROSSING OF THE TOWN'S UTILITY IS AT A 90-DEGREE ANGLE. 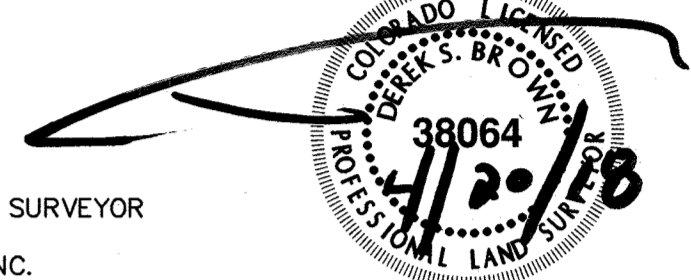

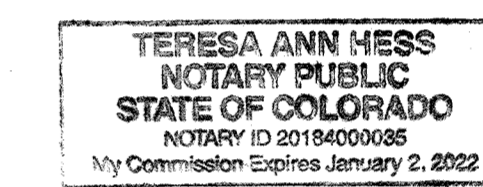

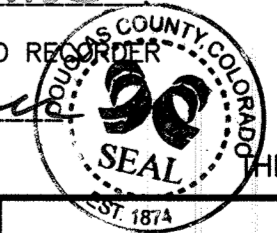
